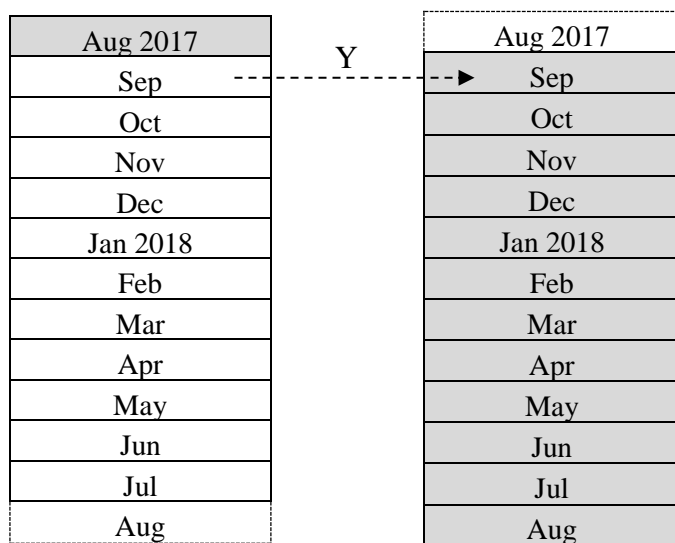

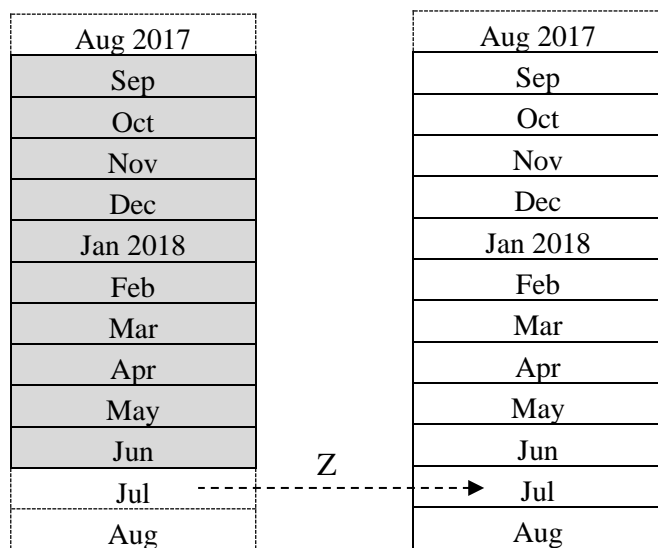


Student Y attends KG A in August, then is transferred from KG A to another Scheme-KG, viz. KG B, from Sep 2017. KG A will receive student Y's subsidy for Aug 2017 and KG B will receive student Y's subsidy from Sep 2017 to Aug 2018.

KG A (starts from Sep with 10 fee instalments)

KG B (starts from Sep with 12 fee instalments)



Student Z is transferred from KG A to another Scheme-KG, viz. KG B, in Jul 2018. KG A will receive student Z's subsidy for a whole school year from Sep 2017 to Jun 2018 [i.e. end of school year]. As such, KG B will not receive any subsidy for student Z.
