Education Bureau Circular No. 13/2024

Kindergarten Education Scheme Guangdong-Hong Kong Sister Kindergarten Exchange Programme

[Note: This circular should be read by –

- (a) Supervisors and Heads of Kindergartens, Kindergarten-cum-Child Care Centres and Schools with Kindergarten Classes joining the Kindergarten Education Scheme – for action; and
- (b) Heads of Sections for information.]

SUMMARY

This circular informs kindergartens, kindergarten-cum-child care centres and schools with kindergarten classes (collectively referred to as "KGs" hereafter) joining the Kindergarten Education Scheme (Scheme-KGs) of the details about the "Guangdong-Hong Kong Sister Kindergarten Exchange Programme" to be launched by the Education Bureau (EDB) starting from the 2023/24 school year.

BACKGROUND

2. To actively promote the professional exchanges and collaboration between KG teachers in the Mainland and Hong Kong (HK), the Chief Executive in his 2023 Policy Address announced the launch of the "Guangdong-Hong Kong Sister Kindergarten Exchange Programme" (the Exchange Programme) starting from the 2023/24 school year to strengthen connection between the Mainland and HK in early childhood education, with a focus on fostering teachers' professional exchanges and collaboration, as well as enhancing the quality of KG education.

DETAILS

3. The Exchange Programme will serve as a platform for professional interflows to facilitate the formation of learning circles among KGs in the Mainland and HK. By the launching of various professional exchange activities through different channels and in diversified modes (e.g. forums, exchange visits, online and offline exchanges), the Exchange Programme will be conducive to promoting the development of KGs in the two places and enhancing teachers' professionalism. EDB will implement the Exchange Programme, starting by inviting 50 HK KGs and 50 KGs from different cities in the Guangdong Province to participate in the Exchange Programme in the first year, and expanding the learning circles gradually as appropriate.

4. The Contract Signing Ceremony-cum-Annual Exchange Activity for the Exchange Programme in the first year is tentatively scheduled to be held in mid-2024. EDB will also provide HK KGs with professional support, by assisting KGs to identify their needs and facilitating KGs to organise exchange activities with Mainland KGs and disseminate good practices, among others.

Application Procedures and Selection Criteria

- 5. All Scheme-KGs may apply for joining the Exchange Programme and applications should be on a per-school basis based on school registration. A Scheme-KG, regardless of the number of its registered locations under the same school registration, will be counted as one eligible KG. Duplicate applications will not be considered further.
- 6. Interested KGs should submit the completed application form (at <u>Annex</u>) <u>on or before 3</u> <u>May 2024</u> by post to the EDB Kindergarten Administration 2 Section (Address: Room 2329, 23/F, Wu Chung House, 213 Queen's Road East, Wan Chai, Hong Kong). Application form (in Word format) can be downloaded from the EDB webpage (Home > Education System and Policy > Kindergarten Education > Kindergarten Education Scheme > 4. Circular).
- 7. EDB will take into account various relevant factors, including the education quality of the KGs (i.e. performance in the aspects of "Management and Organisation", "School Culture and Support for Children", and "Learning and Teaching" in the Quality Review), whether the KGs' overall operating standards in the past were satisfied by EDB (if KGs have been served written warning by EDB due to serious management issues or glaring practices, their applications will not be considered), and whether the KGs have formed Sister KGs with their Mainland counterparts by the signing of formal agreements (regardless of forming as Sister KGs on their own initiative or through other channels), etc., in considering the KGs to be selected for participating in the Exchange Programme in the 2023/24 school year. Selected KGs will be informed within May 2024.
