Kindergarten Education Scheme Training Programme for Kindergarten Supervisors and Managers (2024/25 School Year)

Under the prevailing kindergarten (KG) education policy, KGs joining the Kindergarten Education Scheme (Scheme-KGs) should establish a more participatory school governance framework to enhance transparency and accountability of school governance as well as effectiveness of school operation. The School Management Committee (SMC) is responsible for managing the KG, ensuring that the education of students is promoted in a proper manner. As a member of the SMC, school managers, who play an important role, could help the SMC formulate school-based policies and procedures, monitoring the school's compliance with the Education Ordinance, Education Regulations and other major statutory requirements and guidelines. Therefore, the Education Bureau (EDB) will continue to organise various training programmes for supervisors and managers of Scheme-KGs in the 2024/25 school year.
