Dear Supervisors/ Principals of all Kindergartens (KGs), Kindergartens cum Child Care Centres, Child Care Centres (CCCs) and Special Child Care Centres (KG/CCCs),

#### <u>Invitation to enroll in the</u> 2024/25 Seasonal Influenza Vaccination School Outreach Programme

We are writing to invite all KG/CCCs to enroll in the Seasonal Influenza Vaccination (SIV) School Outreach Programme for the 2024/25 season.

SIV is one of the most effective ways to prevent seasonal influenza and its complications. According to local study, vaccination reduces the risk of influenza-like illness (ILI) in school children by half. Scientific data and research showed that the majority of paediatric cases of influenza-associated severe complication/ death did not receive influenza vaccination. According to local experience, school outreach can double vaccination coverage rates to an average of 70%, effectively strengthening the immunity barrier of school children. SIV can reduce school absenteeism, and also lower influenza transmission in the community.

We would like to express our gratitude for the tremendous support you have provided in the previous academic year for the SIV School Outreach Programme. With your keen support, over 80% of KG/CCCs have enrolled in our Programme, providing over 101,600 doses to KG/CCCs students.

Similar to previous year, schools can enroll in the Seasonal Influenza Vaccination School Outreach (Free of Charge) Programme (SIVSOP) and/or the Vaccination Subsidy Scheme (VSS) School Outreach (Extra Charge Allowed) Programme. For details of each programme and their comparison, please refer to **Annex I** to **III**.

To encourage the uptake of SIV among students, we are pleased to announce that a commendation scheme for the SIV School Outreach Programme will be commenced in season 2024/25. All schools enrolled in the SIV School Outreach Programme will be included in the commendation scheme. Certificates will be awarded to schools with high vaccination coverage.

We hereby remind schools to stay clear of associating with any improper financial (or advantage) transactions with the doctor/ medical organisation and participants of the activity.

Schools are invited to enroll in the Programme by completing the attached **Enrolment Form**. Schools that opted to join SIVSOP through self-selection of doctors should also complete and return **Supplementary Form**. If schools do not intend to join either SIVSOP or VSS School Outreach Programme, we kindly request your careful consideration and return the **Enrolment Form with your reason of not joining the Programme**. All relevant forms should be returned to Programme Management and Vaccination Division of the Centre for Health Protection on or before **15 July 2024** by fax to 2320 8505, or by email to sivop@dh.gov.hk.

# 2024/25 Seasonal Influenza Vaccination School Outreach (Free of Charge) Programme (SIVSOP)

#### Kindergarten (KG)/Child Care Centre (CCC) Outreach

Objectives of the Programme: The Programme aims to facilitate pre-primary institutions, including kindergartens, kindergarten-cum-child care centres, child care centres and special child care centres in arranging outreach vaccination, so as to increase the seasonal influenza vaccination coverage for school children, to reduce school absenteeism, influenza related complications, hospitalisations and deaths, and to reduce influenza transmission in the community.

**Eligibility to join:** Under the Programme, all pre-primary institutions, including kindergartens, kindergarten-cum-child care centres, child care centres and special child care centres can join the Programme. All school children of the participating schools can receive free seasonal influenza vaccination, through Public-Private-Partnership (PPP) vaccination teams\*. School may choose their PPP vaccination team through either *School Self-selection of Doctors or by Department of Health (DH)-matching*.

#### ♦ School Self-selection of Doctors

- i. Schools can choose a private doctor/ medical organisation from the list posted on the Centre for Health Protection website: <a href="https://www.chp.gov.hk/en/features/101413.html">https://www.chp.gov.hk/en/features/101413.html</a>.
- ii. Schools with prior outreach vaccination activities may continue the partnership with the previous doctors/ medical organisations.

#### *♦ DH-matching*

i. For schools which have not selected a private doctor/ medical organisation, DH would match a service doctor\* with the school.

\*For schools in remote areas (e.g. outlying islands) or areas requiring Closed Road Permit or Closed Area Permit (e.g. Lantau Island, Sha Tau Kok), DH may arrange DH Vaccination Team to provide the outreach vaccination service.

**Schedule of the vaccination activities**: The school should fix the dates of vaccination activities for the 1st and 2nd dose with the service doctor. The outreach vaccination activity should be conducted from 9AM to 3PM on Monday to Friday, or 9AM to 11AM on Saturday.

♦ The 1<sup>st</sup> dose should be completed within ONE day. The 2<sup>nd</sup> dose should be completed in another day, with at least 4 weeks apart from 1<sup>st</sup> dose. To ensure adequate immunity against seasonal influenza, children under 9 years of age who have never received any seasonal influenza vaccination before are recommended to receive 2 doses of SIV.

**Types of vaccines being used**: Two types of the seasonal influenza vaccines, injectable type (inactivated seasonal influenza vaccines) and nasal spray type (live attenuated seasonal influenza vaccines) will be available for KG/CCC School Outreach, depending on the availability of the stock and the preference of the school.

- ♦ For schools participating in *School Self-selection of Doctors*, they should discuss with service doctor and <u>mutually agree</u> on <u>the type of vaccine</u> being used, and inform the DH about the choice of the type of vaccine in <u>Supplementary Form</u>.
- ❖ For schools which have not self-selected their doctor, please indicate your preference of type of vaccine in <a href="Enrolment Form">Enrolment Form</a>.

**Delivery arrangement:** For the 1<sup>st</sup> dose activity, DH will arrange the delivery of the vaccines directly to the KG/CCCs; while for the 2<sup>nd</sup> dose, DH will deliver the vaccines directly or via the service doctors to the schools.

Roles and responsibilities of schools: Since schools are provided with vaccination services free of charge, they do not need to conduct tendering or quotation exercise when choosing a doctor. Schools are reminded to stay clear of associating with any improper financial (or advantage) transactions when choosing your service doctor through School Self-selection of Doctor.

Schools are responsible for:-

- 1) Distributing and collecting consent forms;
- 2) Verifying the particulars of the students provided in the consent forms;
- 3) Arranging vaccination venue;
- 4) Preparing the flow for vaccination day(s) (complete the 1<sup>st</sup> dose within 1 day; and completing 2nd dose on another day, with at least 4 weeks apart from 1<sup>st</sup> dose);
- 5) Assisting in the operation of the vaccination team during the vaccination activities; and

6) Providing locked cabinet(s) for temporary storage of clinical waste in case same day collection of clinical waste cannot be arranged.

Application results: The schools will be informed the application and the matching results in August 2024.

#### Vaccination Subsidy Scheme (VSS) School Outreach (Extra Charge Allowed)

Objectives of the Programme: The Vaccination Subsidy Scheme (VSS) School Outreach (Extra Charge Allowed) Programme ("the Programme") aims to facilitate secondary schools, primary schools, kindergartens, kindergarten-cum-child care centres, child care centres and special schools in Hong Kong to arrange outreach vaccination activities to provide free or subsidised seasonal influenza for eligible students and staff.

Eligibility to join: All secondary schools, primary schools, kindergartens, kindergarten-cum-child care centres, child care centres and special schools in Hong Kong are eligible to join the Programme. Schools that are already enrolled in the "Seasonal Influenza Vaccination (SIV) School Outreach (Free of charge) Programme (SIVSOP)" are also eligible to join. All students from participating schools, irrespective of their Hong Kong resident status, are eligible to receive subsidised seasonal influenza vaccination under this Programme. The government will subsidise HK\$260 per dose of SIV and directly reimburse the subsidy to doctors. Some doctors may impose extra fee, while some doctors may not charge extra fee. Persons other than students can also receive SIV in the activity but subsidies would only be provided to persons eligible under VSS¹. Persons not eligible under VSS can also receive vaccination at the same activity at own cost.

**Roles and responsibilities of schools:** Schools should note that vaccination is a medical procedure. Schools and the doctor in-charge of the arrangement must give due consideration to safety and liability issues. Schools are reminded to stay clear of associating with any improper financial (or advantage) transactions with the doctor/medical organisation and participants of the activity.

The school should select a doctor who has enrolled in VSS and will provide outreach

- persons aged 50 years or above;
- pregnant women;
- children aged 6 months to under 18 years (or aged 18 or above and studying in secondary schools in Hong Kong);
- persons with intellectual disability;
- persons receiving Disability Allowance; and
- persons who are recipients of standard rate of "100% disabled" or "requiring constant attendance" under Comprehensive Social Security Assistance (CSSA) Scheme of the Social Welfare Department.

vaccination service at non-clinic settings. Information of enrolled private doctors who will provide outreach vaccination service under the Programme are available at the

Centre for Health Protection (CHP) website (https://www.chp.gov.hk/en/features/46428.html). After selecting a VSS doctor, the school should liaise with the doctor about the terms of service, including arrangement on the venue and dates of the first and second dose vaccination. Once confirmed, the VSS doctor should submit the completed Notification on Vaccination Activity at Non-Clinic Settings form. **Types of vaccines being used**: Injectable type (inactivated) seasonal influenza vaccines or nasal spray type (live attenuated) seasonal influenza vaccines can be used. Schools should discuss with the VSS doctor and **mutually agree** on the type of vaccine being used. **Delivery arrangement:** The purchase and delivery of vaccines should be arranged by the VSS doctor.
