E-LICENSING FOR SCHOOL REGISTRATION

School Registration and Compliance Section Education Bureau



EDB would implement e-licensing in phases

For newly registered schools:

- With effect from 1 July 2024, all certificates of provisional registration and school registration issued by the EDB will be in electronic form with adoption of digital signature and 'e-Proof'(認證易), to replace the traditional manually signed paper certificates.
- Once a school's registration application is approved pursuant to the Education Ordinance, the EDB will issue the electronic Certificate of Provisional Registration and Certificate of Registration (PDF) to the school supervisor by email.

Replacement Exercise in Phases

For registered schools:

- Starting from **September 2024**, the EDB will commence a replacement exercise for schools with paper certificates **in phases**.
- All registered schools under Section 13 of the Education Ordinance would be eligible to obtain their electronic registration certificates **at no cost**.
- Schools are <u>not</u> required to make any application to EDB.
- Their Paper certificates need to be returned to the EDB.

BENEFITS

• Being verifiable:

E-Cert is digitally signed and embeds with an e-Proof, making use of blockchain technology.

• Better accessibility:

Schools can easily access and retrieve e-Cert.

• Saving time:

Schools can receive e-Cert anytime, no longer need to collect in person.

Registration of a school does not release the owners or managers or any other person from compliance with any requirement of the Buildings Ordinance (Cap. 123) or any other Ordinance relating to the school, nor does it in any way affect or modify any agreement or covenant relating to any premises in which the school is operated.



Are there any differences between paper cert and e-Cert ?

- The electronic certificates for school registration possess **the same legal status** as the hardcopy certificates.
- Both certificates **contain the same information**, i.e. school registration number, registered name, its premise address(s), date of issue, period of validity and the responsible officer of the EDB.
- Same as paper certificate, the printed copies and photocopies of electronic certificates for school registration are required to be displayed in a conspicuous place in each of the premises at all times for compliance with the legal requirement.

Are there any differences between paper cert and e-Cert ?

- Each electronic certificate is **digitally signed** by the responsible officer of the EDB.
- The electronic certificate embeds an **e-Proof**.
- Each electronic certificate will contain an encrypted QR code, which is **verifiable** for the certificate holder and the general public.

How to get the e-Cert ?

- The school supervisor will receive the notification message from the EDB, regardless of whether the school is registered or under application.
- Private schools offering non-formal curriculum schools ('tutorial schools') would receive the e-Cert (PDF) by email. The relevant SMS message would be sent to the school supervisor accordingly, if desired.

 Aided, caput, DSS, private primary schools, as well as kindergartens would receive the respective e-Cert (PDF) by the Fast Information Transmission System (FITS) – School Messaging Module (SMM) of EDB.
